C-Span - broadcasted Congressman Dana Rohrabacher <http://rohrbacher.house.gov/> LIVE speaking before the House of Representative.

Congressman Rohrabacher was on **FIRE** blasting out on behalf of Ramos and Compean before the speaker of the house! He pounded his fist on the podium a couple of times! Talk about passion! He did not mince words! WOO HOO!

One of our ralliers called Rohrabacher a "we the people" congressman.

He spoke for about half an hour!

Some of the excellent points Rohrbacher made:

He praised Ramos and Compean over and over as "defenders" of this nation as "heroes"

Sutton prosecuted the good guys and gave immunity to the bad guy

Since their incarceration in January 2007, a propaganda machine has been unleashed against Ramos and Compean by the Bush Administration via Tony Snow, Johnny Sutton, etc

Over 90 members of congress have expressed outrage over the Ramos/Compean case

Drug smuggler Davila's family has verified **Davila always carried a gun**

There are only three witnesses - Ramos, Compean and Drug Smuggler Davila and the government chose to believe the drug smuggler as their star witness

The supervisors present did not witness the event - as there was a 12 foot embankment - they only heard the shots fired

The supervisors did not make a report because it is a five hour paper work task and they thought the drug smuggler got away

So why - he asked - are Ramos and Compean serving criminal time for what was a paper work, administrative issue

Both agents have always maintained that Davila had an object in his hand

Rohrabacher said the jury was **not** allowed to hear evidence on how dangerous the drug running border section is - rather, a "sterile" environment was presented to jury

Rohrabacher said the jury should have been informed about the dangerous area where the event occurred, and that if a drug runner holds an object in his hand, in the heat of battle, it could very likely be a weapon

Three jurors have come forward to state they were coerced to vote for a guilty verdict

It was the supervisors job NOT Agents Ramos and Compean's job to fill out a report - in fact, agents are prohibited from writing up reports

Johnny Sutton went after the supervisors and offered immunity to the supervisors to testify against Ramos and Compean - so they could save themselves from the fact THEY did not write up the incident

Johnny Sutton claims a jury of their peers found Ramos and Compean guilty - however, Sutton kept vital information out of the court proceedings

Davila was involved in drug running October 23, 2005 and Sutton kept this information from the jury

Sutton wrongfully painted Davila as running drugs for the first time, to get money for his sick mother - instead of presenting Davila as a repeat drug smuggler

Johnny Sutton lies to the public to discredit Ramos and Compean. For example, he calls them corrupt law enforcement - when there has never been any charge of corruption

Johnny Sutton lies and says they shot an unarmed man in the back - as if he were a nun or a tourist. In reality, a fleeing drug smuggler was shot in the buttocks - who had an object in his hand

The judge was urged not to let the agents stay out of prison on bond

Rohrabacher pointed out how dangerous prison is to these two agents and presented graphic evidence of the beating Ramos sustained in prison

Ramos and Compean are languishing in solitary confinement, ripped away from family and friends to serve an unjust prison sentence because of the U.S. government - all for risking their lives for the American people!

DHS lied to members of congress to demonize Ramos and Compean - and later called this "misinformation"

DHS official Chris Sanchez let the witness, Davila, stay over night in his home and Chris Sanchez handled the bullet that had been extracted from Davila's buttocks. This was evidence and witness tampering.

So Rohrabacher pointed out that Sutton and DHS allow for their mistakes and mishandling throughout the case BUT just because Ramos and Compean may have been involved in a "paper work" mistake they are in federal prison

DHS and the prosecution are allowed to make mistakes BUT the book is thrown at Ramos and Compean if supervisors made a "paper work" mistake

Rohrabacher finally received a letter from the Department of Justice on the topic of Ramos and Compean. He held the letter up. He said it referenced how DOJ has to be meticulous and not make mistakes

However, Rohrabacher pointed out the letter was address to: Congresswoman Dana Rohrabacher! He said this just represents the contempt the DOJ - Alberto Gonzales - has toward congress

They can make mistakes BUT again he pointed out that just because there may have been a paper work mistake - Ramos and Compean had the book thrown at them!

Rohrabacher was passionate! He was on fire and expressed outrage repeatedly for the wrongful imprisonment of Ramos and Compean

He referred to the upcoming congressional hearing and said they will get the facts before the American people. The above is just a small sample of the evidence, the facts and OUTRAGE Rohrabacher very successfully communicated before the house and the world via C-Span
